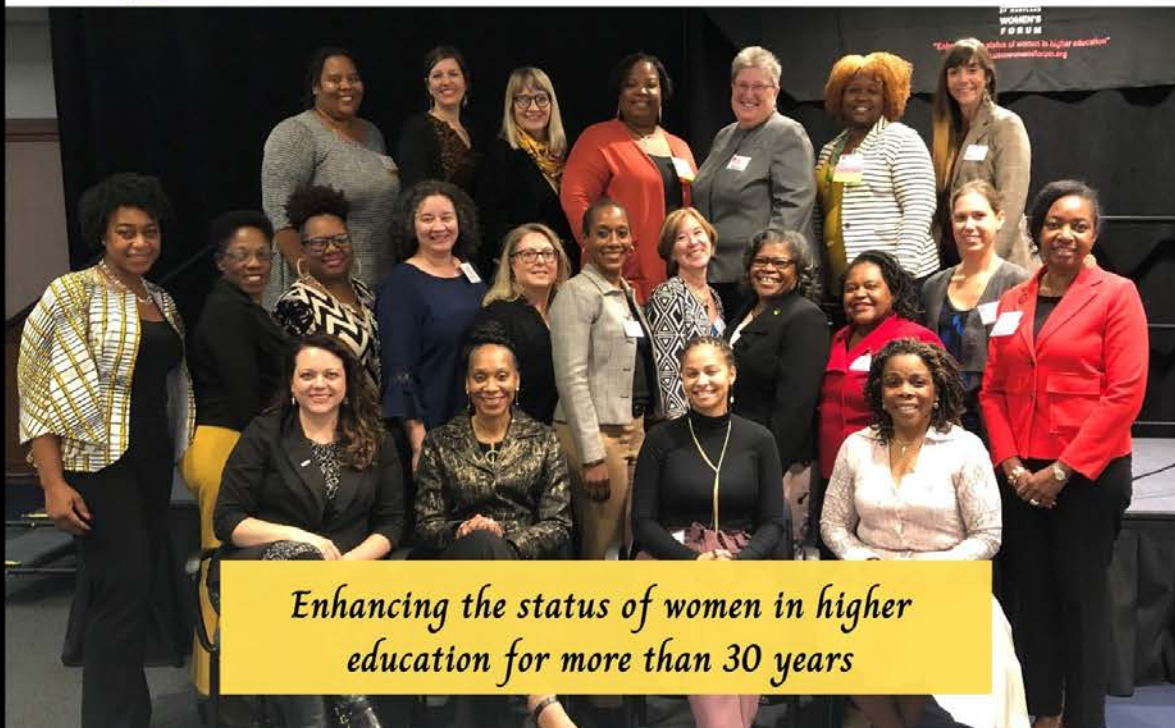

Maryland Commission for Women

A Commission of the Maryland Department of Human Services

The Maryland Commission for Women is a 25-member advisory board first established by the Governor in 1965 and set in state law in 1971. Commissioners are appointed to four-year terms by the Governor, with confirmation by the Maryland State Senate, and serve without compensation. The Commission's duties outlined in its enabling legislation include:

- Study the status of women in our state
- Recommend methods of overcoming discrimination
- Direct attention to critical problems confronting women
- Recognize women's accomplishments and contributions
- Provide informed advice to the executive and legislative branches of government on the issues concerning the women of our state.

- 2021 Maryland Women's Hall of Fame
- 2021 Maryland Young Women Leaders Awards
- Policy and Legislation Advocacy
- 2020 Women's Centennial Summit
- Status of Women in Maryland Research

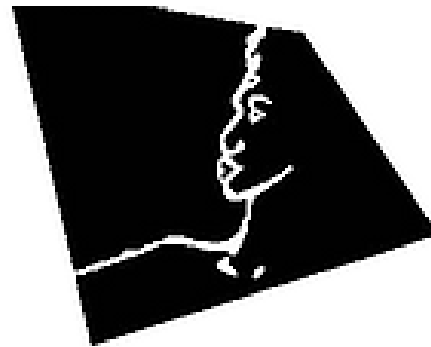
